**ADMINISTRATIVE ORDER 2011 - 10**

**RE: Amendments to St. Lucie Circuit and County Court Judicial Assignments for 2011 and 2012**

**Effective January 23, 2012**

All Dependency Cases, including Shelter Hearings; Model Dependency Court Administrative Judge; Member of St. Lucie County Children Services Council

**Honorable Clifford H. Barnes:**

**Effective November 14, 2011:**

40% of All St. Lucie County Court Criminal Cases; Misdemeanor Drug Court

**Effective January 1, 2012:**

50% of all County Court Criminal Cases, (M – Z) of the alphabet; Misdemeanor Drug Court

**Honorable Kathryn Nelson:**

**Effective November 14, 2011:**

Small Claims Cases including Replevin; All County Ordinance Cases; Assist with Circuit Civil and County Civil Jury Trials

**Effective January 1, 2012:**

Small Claims Cases including Replevin; All County Ordinance Cases; Assist with Residential Mortgage Foreclosure cases; Assist with Circuit Civil and County Civil Jury Trials

**Honorable Philip J. Yacucci:**

**Effective January 1, 2012:**

50% of all St. Lucie County Court Criminal Cases, (A – L) of the alphabet; Domestic Violence Diversion Program (Criminal/DVDP)
