The following holidays will be observed by the Nineteenth Judicial Circuit Court during calendar year 2013:


New Year's Day	Tuesday, January 1, 2013

Veteran's Day	Monday, November 11, 2013
Thanksgiving Day	Thursday, November 28, 2013
Friday after Thanksgiving	Friday, November 29, 2013
Day before Christmas**	Tuesday, December 24, 2013
Christmas Day	Wednesday, December 25, 2013
