RE: 2012/2013 TEEN COURT BUDGET

WHEREAS Senate Bill 2962 of the 2004 Legislative Session allowed for the circuit and counties to continue to use accumulated Teen Court Trust Fund money until it is depleted, and;

WHEREAS Indian River County, Martin County and Okeechobee County collect fees for Teen Court pursuant to s. 939.185(1)(a)4., and St. Lucie County collects fees for Teen Court pursuant to s. 939.19, and;

WHEREAS it is the intent of the Nineteenth Judicial Circuit to continue to run those programs, and;


In accordance with the power and authority vested in the Chief Judge pursuant to Rule 2.215, Florida Rules of Judicial Administration,

It is therefore Ordered:

The Clerks of Court of Indian River, Martin, Okeechobee and St. Lucie Counties shall issue a check in the following amounts from their counties' Teen Court Trust Funds and/or respective funds pursuant to s. 939.185(1)(a)4., F.S. and/or 939.185(1)(a)1., F.S., or s. 939.19, F.S., and forward those checks to the St. Lucie County Clerk of Court to establish the budgets for Teen Court as indicated below by October 1, 2012:

Okeechobee County	10,058
St. Lucie County	<u>106,066</u>
TOTAL:	\$ 189,383
