It is your responsibility to track your case and be in full compliance with the Court's Order Setting Pretrial Procedures.

**CASE SETTLEMENT:** It is the responsibility of Plaintiff's Counsel to fax a letter of settlement to the Judge's Office at 772-462-1201 as soon as the case settles. No approval is required for this type of fax.

**CONTINUATION/ROLLOVERS:** Just because your case is continued to another Calendar Call/Docket Call it does not mean **cut-off dates** have been extended or that another pretrial order will be entered by the Court. You must address this issue at Calendar Call/Docket Call, by stipulation and/or by hearing. **If you believe there is an error on this calendar please contact the J.A. immediately.
