**ATTENDANCE AT JURY SELECTION/WEEKLY TRIAL CALENDARS:** You must appear on the date of your trial ready to pick a jury even if the case(s) ahead of you announce ready for trial. Do not call the Judicial Assistant concerning the Weekly Jury Selection/Trial Calendars. It is your responsibility to track your case and be in full compliance with the Court's Order Setting Pretrial Procedures.

**CASE SETTLEMENT:** It is the responsibility of Plaintiff's Counsel to fax a letter of settlement to the Judge's Office at 772-462-1201 as soon as the case settles. No approval is required for this type of fax.

**CONTINUATION/ROLLOVERS:** Just because your case is continued to another Calendar Call/Docket Call it does not mean cut-off dates have been extended or that another pretrial order will be entered by the Court. You must address this issue at Calendar Call/Docket Call, by stipulation and/or by hearing. **If you believe there is an error on this calendar please contact the J.A. immediately. **COMPLIANCE WITH PRETRIAL ORDER:** Your pretrial statement was due before or at Calendar/Docket Call. Please make sure that your pretrial statement has been filed. You must mark and file your exhibits with the Court Clerk at least 48 hours in advance of trial. Please make sure that your exhibits are in order for the clerk.
