A copy will be available in the courtroom the day of calendar/docket call. Please Note: There are other cases that are currently set for trial. If these cases do not settle or are not reached on the court's trial docket they will be continued to the next Docket Call as a rollover or continuance. It is your responsibility to track your case position on the Trial Docket.*
