Unless you have received an Order to the contrary or you have been advised by the Court/JA, you must appear when your case is scheduled.</i></p> <p align="center"><b><u>MUTUALLY  AGREEABLE TRIAL  DATES</u></b></p> <p>Please check the Court’s monthly online calendars for actual trial weeks. The parties should attempt to discuss mutually agreeable trial dates before attending Docket Call.</p>
<p><b><u>CASE TRACKING</u></b></p> <p>If a case settles, Plaintiff’s counsel <b>must</b> email a letter advising the Court of same prior to the trial date so that the case may be removed from the trial calendar. If you do not email a letter of settlement and you do not appear for weekly calendar call, your case will be dismissed.
