Re: Linn Division Updated COVID-19 Procedure

Pursuant to Chief Justice Canady's Administrative Orders and Chief Judge Mirman's Administrative Orders, the Linn Division will be conducting hearings using the procedures outlined below. I have emphasized amendments by italics and/or bold

### 1. Probate and Guardianship

All Civil, Unified Family Court, Probate, and Guardianship hearings ***MUST be by ZOOM*** until further notice. Parties who have UMC and specially set hearings need to contact my office at [IRCJudge5@circuit19.org](mailto:IRCJudge5@circuit19.org) and provide a list of e-mails for everyone wanting to participate in the ZOOM hearing. *The list of e-mails must be provided by 4:00PM the Friday prior to the hearing date and failure to do so will result in the hearing being cancelled.* Any evidence used at the hearing must be filed in the Court file five days in advance.

The Court will continue to process the paperwork for Probate and Guardianship cases that do not require a hearing.

Any injunction or emergency temporary guardianship hearings must be scheduled through my office at [IRCJudge5@circuit19.org](mailto:IRCJudge5@circuit19.org). Emergency hearings will be set at 1:00PM. Likely, these hearings will be by ZOOM, but will be determined on a case by case basis.

### 2. Dependency

All Dependency trials will be conducted in person.

All other dependency hearings will be conducted on ZOOM. Personal appearances will be left to the discretion of the Court on a case by case basis and in accordance with the latest administrative orders.

All Shelter hearings will continue as scheduled at 8:45AM via ZOOM. Anyone can personally come to the courtroom to utilize the ZOOM technology if they wish.

### **3. Risk Protection Orders**

All risk protection orders shall remain as scheduled on ZOOM. Parties wishing to personally appear should contact my office prior to the hearing. Risk protection hearings will be scheduled at 1:00PM.

### **4. Delinquency**

Detention hearings shall be in person. If the child is in secure detention, DJJ may have the child appear by ZOOM. All parents must personally appear in the courtroom.

### **5. Specialty Courts**

Drug Court and Truancy Court will be done in person.
